

**46th Annual Algonac Art Fair**  
**SATURDAY & SUNDAY, September 1<sup>st</sup> & 2<sup>nd</sup>, 2018**

**TIME:** 10:00 AM until 6:00 PM Saturday/10:00 AM until 5:00 PM Sunday, rain or shine. Exhibitors must be in attendance both days with sufficient stock to sell. Booth must be open and intact until closing.

**PLACE:** Algonac City Riverfront Park, St. Clair River Drive, Algonac, Michigan

**MEDIA:** Fine Art, Mixed Media, Graphics, Printmaking, Photography, Sculpture, Basketry, Clay, Leather, Wood, Glass, Fiber, Jewelry, Enamel, Batik, Wearable Art and other original quality artwork. **No kits or commercial products. All art displayed must be included in your application.**

**RULES OF ENTRY:**

Each applicant must submit a minimum of five photographs (including booth and art work showing how art work is made). Please label all pictures with name, title and material. **PHOTOS WILL BE RETURNED AT THE FAIR (if you have not been accepted, we will return photos to you).** Exhibitors must be in attendance both days with sufficient stock to sell. **If you sell out, you must display a "Sold Out" sign on your tent and remain fully set up until closing on Sunday.** Failure to comply will result in not being invited to the fair the following year.

**AWARDS:**

Cash prizes and ribbons. Ribbons will be presented the first day of the show. Prize money will be awarded at the end of the show. Winners must be in attendance both days.

**FEE:** Booth spaces are 12' x 12'. Fees are non-refundable. Single booth is \$175. One + one-half booth is \$250.00. Double booth is \$300.00.

**ACCEPTANCE:**

All applications are due by **JUNE 30, 2018.** Notification of acceptance or rejection will be mailed to you within 30 days of receipt of your application. At that time, your check will be deposited or returned. A copy of the agreement signed by all parties will be on file at the show. Upon acceptance, **fees are non-refundable in the event that the show cannot be held due to weather, acts of God or other circumstances beyond the control of the Art Fair Committee.**

**SET-UP:** Report to Information Booth located in the middle of the fair across from Chemical Bank. You will then receive your space number and other important information. **NO SPACE NUMBERS WILL BE GIVEN IN ADVANCE (space numbers may change slightly from year to year).** Each participant must furnish their own set-ups, tables and tents, etc. **Please no tarp-like tents.** Friday night set-up is available for anyone from **4 PM to 7 PM.** Set-up time on Saturday will be from **7:00 AM to 9:00 AM.** The St. Clair County Sheriff requests that there be **NO DOUBLE PARKING** and that you unload your vehicle completely and proceed to the official parking area before setting up exhibit. Artists' Shuttle service will be provided starting at 7:00 AM on Saturday. **ELECTRICITY IS AVAILABLE upon request. NO PETS PLEASE OR CARS ALLOWED IN THE PARK. Artists are requested to remove anything of value from their booths Friday and Saturday nights. The Algonac Art Fair will not be responsible for loss or damage of any art work or personal items during fair.**

**SALES:** All sales will be transacted and collected by the exhibitor. Each exhibitor is responsible for his/her own payment of the Michigan State Sales Tax.

**LIABILITY:**

The Algonac Art Fair Committee accepts no responsibility or liability for loss, theft or damage to any exhibitor's property or injury to exhibitors sustained while on the premises of this designated Art Fair or designated parking area. Your signature on this application and lease agreement form constitutes your agreement to the terms and conditions stated herein, and no other terms, conditions or promises shall be binding.
